

**AMENDMENT: MILESTONE
DEMOCRATIC SCHOOL and GET IT
RIGHT EDUCATORS' COOPERATIVE
CONTRACT**

THIS AMENDMENT to the agreement entered into as of **1st July, 2023** by and between **Milestone Democratic School, Inc.**, a Wisconsin nonprofit corporation charter school (“**School**”) and **Get It Right Educators’ Cooperative**, a Wisconsin Cooperative (**Get It Right**), is made and entered into effective as of 16th November, 2023.

Amendment B: Payment Terms

This Amendment replaces all previously-agreed-upon payment schedules and amounts.

This Amendment assumes no incurred debt from the original payment schedule for the 2023-24 Master Contract, to which this is an Amendment. I.e. this Amendment assumes that the School and Get It Right are beginning with a zero balance for the current school year’s services. Prior debts (i.e. the unpaid balance from the 2022-23 Master Contract) are not affected by this Amendment.

Accordingly, the School and Get It Right hereby agree to the following revised invoicing and payment schedule, along with allocations, through January 30th, 2024. If no subsequent Amendment is approved by the School and Get It Right before January 30th, 2024, detailing payment schedule for the period of February 1st through June 30th, 2024, then this contract as a whole will be terminated.
